## Regular Town Board Meeting Minutes Tuesday, April 8, 2025 Community Center, 5:00 p.m.

Chairman Cushing called the meeting to order and noted that it was posted, published, and handicapped accessible in accordance with Wisconsin Open Meeting Laws.

Chairman Cushing introduced the new member of the board who was elected April 1, 2025, Jeff Verdoorn.

A moment of silence was observed to honor our troops here and abroad. Pledge of Allegiance was spoken.

Present: Chairman Cushing, Supervisor Fuhrman, Supervisor Verdoorn and Clerk Myshchyshyn. Treasurer Murdoff was away.

Motion by Fuhrman, second by Verdoorn to approve the agenda as read. Motion carried.

Motion by Fuhrman, second by Cushing to approve the minutes from March 11, 2025, regular board meeting as posted. Verdoorn abstained, Motion carried.

Motion by Fuhrman, second by Verdoorn to approve the Treasurer's report as read. Motion carried.

Messages/Announcements/Correspondence/Bid Submissions: Building Permits were presented. The Kids Snowmobile Racing Club gave a plaque to Lake Katherine as Track of the Year and thanked the community for its continued support. Chairman Cushing also announced that the Community Building loan has been paid off.

- 1. Town crew maintenance report: Matt Strasburg Hopefully they are finished plowing for the season. All machines are in good working order. There are 8-10 tons of salt/sand left, they will either cover it or move it to Minocqua for storage. They started cleaning up all the trees and limbs that fell during the ice storm and will chip when road limits are off. They have been performing maintenance and oil changes on the Fire Department vehicles. The letters for the Hazelhurst sign have arrived. They will put something behind the letters to make it stronger. There was damage sustained to the bathrooms at the public landing, roof and power line damage. The electric will be fixed as soon as they can get someone out. Supervisor Fuhrman asked if the crew had signs to mark when powerlines are down. Strasburg suggested that they use old road signs and have stickers made up to indicate powerline down. The board directed that that should happen.
