 Town crew maintenance report: Road weight limits were instated on February 26, 2024. There were repairs made on Truck #4, and the excavator. Repairs were completed on the dock at McCormick Lake and new boat bumpers were also installed. Some of the playground equipment was also repaired. The culvert inventory is almost complete.

The Plan Commission then reviewed a preliminary eight (8) lot County Plat of Yawkey View Estates, Brandon and Kristin Newman Revocable Trust, owner, and submitted by Vreeland Associates, Inc., Timothy Vreeland, Surveyor, for the following vacant lands further described as; Lots 1 and 2, CSM 5434, being a part of Government Lot 1, and part of the NE-NE, section 22, T38N, R6E, PIN's HA 294 and HA 295, Town of Hazelhurst. Motion to approve based on county rezoning from Residential Farming to Single Family Residential by Knoebel, second by Carothers. Motion carried. Carothers suggested that Tourist Rooming House permits be discussed for possible amendments as part of the upcoming 10-year Plan for Hazelhurst. Motion by Cushing, second by Fuhrman to sponsor recommendation for the a preliminary eight (8) lot County Plat of Yawkey View Estates, Brandon and Kristin Newman Revocable Trust, owner, and submitted by Vreeland Associates, Inc., Timothy Vreeland, Surveyor, for the following vacant lands further described as; Lots 1 and 2, CSM 5434, being a part of Government Lot 1, and part of the NE-NE, section 22, T38N, R6E, PIN's HA 294 and HA 295, Town of Hazelhurst, to be rezoned from Residential Farming to Single Family Residential. Supervisor Schmitz abstained. Motion carried.

6. Motion by Cushing, second by Schmitz to approve a 2024 contract with USDA-APHIS-WIS beaver

damage control program. Motion carried.

7. Discussion regarding complaints of snowmobile racing on Lake Katherine. The complaint had to do with the noise of the snowmobiles interrupting ice fishing. Discussion was about how unusual a year it was for snowmobile racing with little snowfall this winter. They don't usually come to Lake Katherine, but as there was no other place safe, the youth clubs asked for permission to race on Lake Katherine. Permission was granted by the chairman. Complaint was duly noted.
