

Regular Town Board Meeting Minutes
Monday March 20, 2023
Community Center, 5:00 p.m.

Chairman Cushing called the meeting to order and noted that it was posted, published, and handicapped accessible in accordance with Wisconsin Open Meeting Laws.

A moment of silence was observed to honor our troops here and abroad. Pledge of Allegiance spoken.

Present: Chairman Cushing, Supervisor Kettner, Treasurer Murdoff and Clerk Myshchyshyn. Supervisor Lee was absent.

Motion by Kettner, second by Cushing to approve the agenda as read. Motion carried.

Motion by Cushing, second by Kettner to approve the minutes of the February 14, 2023, regular town meeting and the February 20, 2023, special meeting as posted and received. Motion carried.

Motion by Cushing, second by Kettner to approve the Treasurer's report as read. Motion carried.

Messages/Announcements/Correspondence/Bid Submissions: Three building permit were reviewed.

Public Input – None

1. Town crew maintenance report: Crew have spent much time in snowplowing. There is 94" of snowfall so far. Major repairs were completed on truck 1 and minor repairs were made on truck 2. Weight limits went into effect on March 20, 2023 and the salt sand order for next year has been placed.
2. Plan Commission report: The plan commission met March 7, 2023. They reviewed a sign application for P&A Good Life, LLC, Country Charm Floor Care, Jennifer Pockat, owner. The sign will be placed on a building at 6843 Hwy 51, Hazelhurst. Motion to approve by Knoebel, second by Bergeon. The commission then reviewed a Tourist Rooming House Administrative Review Permit application by Erika Doll, applicant, Dana Doll, owner, to rent the dwelling as tourist rooming house for no less than seven (7) consecutive days on the following described property: Part of Government Lot 4, Section 3, T38N, R6E, PIN #HA 602-2, 7160 Minocqua Road, Town of Hazelhurst. Motion to approve by Knoeble, second by Bergeon. Commissioner's report, Carothers brought to attention the Comprehensive Plan should be looked at for possible amendments regarding Tourist Rooming House Permits.
3. There was discussion regarding the snowmobile trail that runs along Oak Drive. Residents have complained about safety issues with people driving their snowmobiles too fast and that with grooming, the road is only one lane. Chairman Cushing told the snowmobile club that these issues needed to be resolved or they would no longer have permission to use Oak Drive as part of their trail. It was determined that the snowmobile club would not groom on Oak Drive so that the town plows could remove excess snow. It was also determined that proper signage be posted. Chairman Cushing said that we will see how this works.
4. Motion by Cushing, second by Kettner to approve the sign application for P&A Good Life, LLC, Country Charm Floor Care, Jennifer Pockat, owner. The sign will be placed on a building at 6843 Hwy 51, Hazelhurst. Motion carried.

5. Motion by Kettner, second by Cushing to approve with restrictions noted by Oneida County, a Tourist Rooming House Administrative Review Permit application by Erika Doll, applicant, Dana Doll, owner, to rent the dwelling as tourist rooming house for no less than seven (7) consecutive days on the following described property: Part of Government Lot 4, Section 3, T38N, R6E, PIN #HA 602-2, 7160 Minocqua Road, Town of Hazelhurst. Motion carried.
6. Motion by Kettner, second by Cushing to approve a server's license for Jennifer Emm Lepak. Motion carried.
7. Board discussed reviewing ATV/UTV reports and ordinance. A request for further signs was noted.
8. Tabled setting the date for road inspections until next month.
9. Chairman Cushing reminded everyone about the upcoming Annual Meeting which will be held April 18, 2023, at 5:00 p.m.
10. Motion by Cushing, second by Kettner to approve the payment of bills. Motion carried.
