

Regular Town Board Meeting Minutes

Tuesday, April 12, 2022

Community Center, 5:00 p.m.

Chairman called the meeting to order and noted that it was posted, published, and handicapped accessible in accordance with Wisconsin Meeting Laws.

A moment of silence was observed to honor our troops here and abroad.

Present: Chairman Cushing, Supervisor Kettner, Supervisor Lee, Treasurer Murdoff and Clerk Myshchyshyn.

Motion by Kettner, second by Lee to approve the agenda as read. Motion carried.

Motion by Kettner, second by Lee to approve the minutes of the March 3rd regular town meeting, minutes from the Special Town meeting on March 17th for the discussion of bids for the addition on the fire barn and the minutes for the Special Town meeting on March 31st to discuss and approve bids for the addition on the fire barn, as posted and received. Motion carried.

Motion by Lee, second by Kettner to approve the Treasurer's report as read. Motion carried.

1) Town crew maintenance report: Town crew haven't had to plow since March 21st. They have been sanding roads, cleaning up trees and branches from ice storms. Some are still stuck in the ice and snow. Repairs were made to the tractor for mowing. They also fixed and painted the playground equipment.

2) Plan Commission report: Did not meet

3) Chairman Cushing gave the second reading of Ordinance 22-01 Non-Sufficient Funds Checks. Motion by Lee, second by Kettner to approve Ordinance 22-01 as read. Motion carried.

4) Board discussed hiring a person to mow and maintain park and Lake Katherine beach and landing. It is not possible to hire someone from McNaughton this year. The Board asked if the person hired last year was willing to work again this year. Matt Strasburg said they had communicated with that person, and he was available. Matt will contact him and have him come to the town office to fill out all needed paperwork.

5) Date for road inspections is set for May 16, 2022, at 6:00 a.m. May 20, 2022, was set as an alternate day.

6) The town crew is suggesting that we pave approximately .27 miles of North Yawkey Lake Road, 20 ft snowmobile crossing on Oneida Street and 150 ft on South Kaubashine Road, and crack seal approximately 1.2 miles of roads including parts of Cedar Falls Road, Semrau Trail, Church Street and West Yawkey Street. Motion by Cushing, second by Lee to let out bids for road projects and crack sealing. Motion carried.

7) Motion by Lee, second by Kettner to hire Peterson Metz to help with State of Wisconsin Form CT. Motion carried.

Motion by Kettner, second by Cushing to approve the payment of bills. Motion carried.
