

Regular Town Board Meeting Minutes

Tuesday, September 13, 2022

Community Center, 5:00 p.m.

Chairman Cushing called the meeting to order and noted that it was posted, published, and handicapped accessible in accordance with Wisconsin Meeting Laws.

A moment of silence was observed to honor our troops here and abroad. Pledge of Allegiance spoken.

Present: Chairman Cushing, Supervisor Kettner, Supervisor Lee, Treasurer Murdoff and Clerk Myshchysyn.

Motion by Kettner, second by Lee to approve the agenda as read. Motion carried.

Motion by Lee, second by Kettner to approve the minutes of the August 8, 2022, regular town meeting and the minutes from the Special Town Board meeting for the budget process, September 15, 2022, as posted and received. Motion carried.

Motion by Kettner, second by Lee to approve the Treasurer's report as read. Motion carried.

Messages/Announcements/Correspondence/Bid Submissions: There were two building permits from Oneida County.

1. Town crew maintenance report: All the mowing on the sides of the roads, two passes, has been completed. A cul-de-sac on Leisure Drive is being worked on. All the shoulders have been pulled back on Lower Kaubashine. The road projects are almost completed, just waiting for the snowmobile crossing on Oneida Street to be finished.
2. Plan Commission report: The Plan Commission met on September 6, 2022. A motion was made by Carothers and second by Rhyner to approve a request by Greg Maines, of Maines and Associates Land Surveyors, on behalf of Darrell R. Young Revocable Trust to reconfigure the lot lines for HA 608-2 and HA 608-4, Town of Hazelhurst. Motion carried. A motion was made by Carothers, second by Rhyner to forward for approval as applied a Tourist Rooming House Administrative Review Permit application submitted by Mark Barth, applicant and owner, to rent the dwelling as tourist rooming house for less no less than seven (7) consecutive days on the following described property: Leisure Shores Subdivision, Lot 39, Section 32, T38N, R6E, PIN #HA 809, 10381 Leisure Drive, Town of Hazelhurst. Motion carried. A motion was made by Schlecht, seconded by Rhyner to approve the request for an Administrative Review Permit application by Adam Jones, applicant and owner, to operate a tattoo shop on the following described property, Village of Hazelhurst, Part of Outlot 7, Section 3, T38N, R6E, 7045 Highway 51, PIN # HA 606-12, Town of Hazelhurst. Motion carried.
3. The board tabled the discussion on the documents for the room tax from Greg Harrold until the members have a further chance to review them.
4. Motion by Kettner, second by Lee to approve a request by Greg Maines, of Maines and Associates Land Surveyors, on behalf of Darrell R. Young Revocable Trust to reconfigure the lot lines for HA 608-2 and HA 608-4, Town of Hazelhurst. Motion carried.
5. Motion by Kettner, second by Lee to approve a Tourist Rooming House Administrative Review Permit application submitted by Mark Barth, applicant and owner, to rent the dwelling as tourist rooming house for less no less than seven (7) consecutive days on the following described property: Leisure Shores Subdivision, Lot 39, Section 32, T38N, R6E, PIN #HA 809, 10381 Leisure Drive, Town of Hazelhurst. Motion carried.
6. A motion was made by Cushing, seconded by Lee to approve the request for an Administrative Review Permit application by Adam Jones, applicant, and owner, to operate a tattoo shop on the following described property, Village of Hazelhurst, Part of Outlot 7, Section 3, T38N, R6E, 7045 Highway 51,

PIN # HA 606-12, Town of Hazelhurst, provided they follow Oneida County stipulations and complete a sign application for their billboard. Motion carried.

7. Motion by Kettner, seconded by Lee to approve the change in the snowmobile route as discussed on Oak Drive if the proper signage is in place. Motion carried.
8. Motion by Lee, seconded by Kettner to approve a Server's License for Jeanne Marie Peskie. Motion carried.
9. Plans for repairing and possible construction of pickleball courts were discussed. The current tennis court needs to be repaired. The board plans to discuss this further.
10. Dates were set for further budget discussions for September 20, 2022, at 3:00 p.m. and September 26, 2022, at 3:00 p.m.
11. Motion by Kettner, second by Lee to approve the payment of bills. Motion carried.
